

## LCSC Minutes

November 6, 2017

In attendance: Sarah Shipley, Bonnie Grenon, Dwayne Sales, Anita Slovak, Maryanne Morrison, Michelle Klapatiuk, Karcsi Peter, Roland Jarrett

1. Alpine Jackets: Sarah managing alpine jackets when they get here. 9 should be arriving soon. Michelle will forward invoice to Maryanne, who will pay it. Need to do up a policy for jacket rental – jacket is \$300, so replacement cost if jacket lost. Jacket needs to come back clean at end of season. Rental \$100, \$50 will be returned at end of season when jacket is returned.
  - a. Can ask for sponsorship – letter should go out with Alpine athletes. Club decides on placement of logo. \$500 is sponsorship for jacket logo-ing – will be on there for the life of the jacket, as well as any additional jackets that need to be added to the collection for 3 years. Sponsors will go on website as well (at the bottom). Sponsorship letter is on the google drive.
2. Club Cabin addition: thanks to all who worked on it! Pictures on facebook page. John Marien building barn doors for it. Community Foundation gave us \$5000 for the Club Cabin; Community Futures was \$2500 for the Club Cabin – should be two separate amounts from Community Futures, the other one was for stopwatches. Invoices will come from scaffolding, Mike Smyth, Troll (meals), Backer (gravel), roofing, etc. Michelle will gather these and submit.
3. Mail keys have gone to Roland Jarrett.
4. Volunteer Hours: Charge money at the initial registration. Get it back after your family volunteers 15 hours in a season. Need to create a volunteer log in the club cabin so that people can log their hours – we can use this for grant requests in the future. 2017-18 will track the hours; 2018-19 will implement charging.
5. Club Cabin Posters – Roland will try printing them out at work first. If that doesn't work out, Big Country Printers: 11x17 = \$20; 20x24 = \$30 (quote that Bonnie got).
6. Yurt: Michelle and Hildur had telephone conversation (a month-ish ago) about not getting the yurt application for this year – application complicated and need time for prep, shipment, etc. Michelle has proposed doing this next year if Troll still interested, as time too short for 2017. Michelle will forward grant application to Jen B. who will help fill it out for September 2018. Troll will need to come up with full \$30,000 to purchase + labour, etc.
7. Registration: When will we close it? Dec. 25. After that, there will be a \$50 late fee charge.
8. Sun Peaks camp this week: new coach Alefa Sakakibara mentoring with Hervé – Jen B. motioned to pay Alefa for her days at Sun Peaks for the three days on snow (daily rate as per her contract), and her expenses as well. Michelle 2<sup>nd</sup>. AIF.
  - a. Michelle needs cash for the Sun Peaks condo rental. Maryanne will send her e-transfer (\$600) – condo is \$400, cleaner is \$200.
9. Michelle invited Timothy members to coaches course and officials course.
10. Brian Bennett will come out this season to ski with the team at various times.
11. Bonnie: Confirmation from Scott that he has skills training & Ski School – Bonnie doing advertising for Ski School on the LCSC page; will advertise LCSC on Troll page.
