Motion to open a separate bank account for money received from Northern Development: Moved by *Karcsi, seconded by Julie. Motion carried with all in favour.* *These funds are reserved for allocation as per our application to NDIT. We received \$70 287.75 from NDIT.

NDIT funds bank account—Rene needs to drop off a letter on letterhead with 2 board signatures stating that we want to put the NDIT money in a separate account. This will help in grant writing purposes to show that this money is already allocated for specific purposes. NDIT money will need to be shown as reserved funds for the gaming account.

Coaching BC Winter Games–Michelle coached 10 athletes at BC Winter Games. *Motion to pay Grace's daily fee to Michelle Kadenbach for days spent coaching at BC Winter Games: Moved by Rene, seconded by Kristyna. Motion carried with all in favour.* Payment to be made to Michelle in the form of a family credit.

Grooming payment to Hildur for this season and coach passes– Payment amount due to Troll to be calculated. Troll to get a receipt for gold sponsorship. We have one pass reimbursement to make to coach Keri. Next season, all coach passes to be provided directly through the club. Karcsi to determine who's passes the club owes for and to pass on the Rene.
